PhillipMart Announces Pre-IPO Share Price of Lumina Group Limited (Stock code: 08470)

(Hong Kong – 24 Oct 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Lumina Group Limited** (Lumina Group; stock code: 08470) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Lumina Group** on PhillipMart were HK\$0.54 and HK\$0.47. The price closed at HK\$0.47 per share,2.17% higher than its offer price of HK\$\$0.46. The price opened at HK\$0.53, with the most actively traded price of HK\$0.475 per share, and a turnover of 1,840,000shares. The total trading volume reached 7,560,000shares with **total turnover of HK\$3,663,080.00**. The final price of **Lumina Group**, to debut trading on 25 Oct. It has been fixed at HK\$0.46 per share.
