

PhillipMart Announces Pre-IPO Share Price of KIDSLAND INTERNATIONAL HOLDINGS LIMITED (Stock code: 02122)

(Hong Kong – 9 Nov 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of KIDSLAND INTERNATIONAL HOLDINGS LIMITED (Crystal International; stock code: 02122) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for KIDSLAND INTL on PhillipMart were HK\$2.7 and HK\$1.8. The price closed at HK\$1.93 per share,24.52% higher than its offer price of HK\$\$1.55. The price opened at HK\$2.49, with the most actively traded price of HK\$1.9 per share, and a turnover of 3,968,000shares. The total trading volume reached 16,338,000shares with total turnover of HK\$34,272,640.00. The final price of KIDSLAND INTL, to debut trading on 3 Nov. It has been fixed at HK\$1.55 per share.
