

**PhillipMart Announces Pre-IPO Share Price of  
 RAZER INC. (Stock code: 01337)**

(Hong Kong – 10 Nov 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **RAZER INC.** (Stock code: 01337) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **RAZER INC.** on PhillipMart were HK\$5.13 and HK\$4.55. The price closed at HK\$4.65 per share, 19.85% higher than its offer price of HK\$3.88. The price opened at HK\$4.69, with the most actively traded price of HK\$5 per share, and a turnover of 7,835,000 shares. The total trading volume reached 56,758,000 shares with **total turnover of HK\$276,925,280.00**. The final price of **RAZER INC.**, to debut trading on 13 Nov. It has been fixed at HK\$3.88 per share.
