

## PhillipMart Announces Pre-IPO Share Price of VERTICAL INTERNATIONAL HOLDINGS LIMITED (Stock code: 08375)

(Hong Kong – 10 Nov 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **VERTICAL INTERNATIONAL HOLDINGS LIMITED** (Stock code: 08375) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **VERTICAL** on PhillipMart were HK\$0.5 and HK0.34. The price closed at HK\$0.5 per share,66.7% higher than its offer price of HK\$\$0.3. The price opened at HK\$0.34, with the most actively traded price of HK\$0.48 per share, and a turnover of 340,000shares. The total trading volume reached 2,440,000shares with **total turnover of HK\$1,133,900.00.** The final price of **VERTICAL.**, to debut trading on 13 Nov. It has been fixed at HK\$0.3 per share.
