PhillipMart Announces Pre-IPO Share Price of Sun Hing Printing Holdings Limited (Stock code: 01975)

(Hong Kong – 15 Nov 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Sun Hing Printing Holdings Limited (Sun Hing Print; stock code: 01975) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sun Hing Print** on PhillipMart were HK\$1.6 and HK\$1.43. The price closed at HK\$1.51 per share,9.42% higher than its offer price of HK\$\$1.38. The price opened at HK\$1.5, with the most actively traded price of HK\$1.56 per share, and a turnover of 1,136,000 shares. The total trading volume reached 5,616,000shares with total turnover of HK\$8,565,560.00. The final price of Sun **Hing Print**, to debut trading on 16 Nov. It has been fixed at HK\$1.38 per share.
