

PhillipMart Announces Pre-IPO Share Price of Yixin Group Limited (Stock code: 02858)

(Hong Kong – 15 Nov 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Yixin Group Limited** (Yixin Group; stock code: 02858) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Yixin Group Limited** on PhillipMart were HK11.5 and HK\$10.32. The price closed at HK\$10.94 per share,42.08% higher than its offer price of HK\$\$7.7. The price opened at HK\$10.5, with the most actively traded price of HK10.5 per share, and a turnover of 5,091,000shares. The total trading volume reached 32,731,000shares with **total turnover of HK\$349,072,000.00**. The final price of **Yixin Group Limited**, to debut trading on 16 Nov. It has been fixed at HK\$7.7 per share.
