## **PhillipMart Announces Pre-IPO Share Price of** Bestway Global Holding Inc. (Stock code: 03358)

(Hong Kong – 15 Nov 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Bestway Global Holding Inc.** (Bestway Global; stock code: 03358) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bestway Global on PhillipMart were HK\$4.38 and HK\$4.05. The price closed at HK\$4.19 per share,4.34% lower than its offer price of HK\$\$4.38. The price opened at HK\$4.38, with the most actively traded price of HK\$4.16 per share, and a turnover of 516,000shares. The total trading volume reached 974,500shares with total turnover of HK\$4,068,775.00. The final price of Bestway Global, to debut trading on 16 Nov. It has been fixed at HK\$4.38 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
