

## PhillipMart Announces Pre-IPO Share Price of Bortex Global Limited (Stock code: 8118)

(Hong Kong – 15 Nov 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Bortex Global Limited ("Bortex Global"; stock code: 8118) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bortex Global on PhillipMart were HK\$0.47 and HK\$0.4. The price closed at HK\$0.42 per share, 40.00% higher than its offer price of HK\$0.3. The price opened at HK\$0.4, with the most actively traded price of HK\$0.435 per share, and a turnover of 568,000 shares. The total trading volume reached 2,368,000 shares with **total turnover of HK\$1,031,800.00**. The final price of **Bortex Global,** to debut trading tomorrow has been fixed at HK\$0.3 per share.
