

## PhillipMart Announces Pre-IPO Share Price of INDIGO STAR HOLDINGS LIMITED (Stock code: 8373)

(Hong Kong – 15 Nov 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of INDIGO STAR HOLDINGS LIMITED ("INDIGO STAR"; stock code: 8373) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for INDIGO STAR on PhillipMart were HK\$0.76 and HK\$0.63. The price closed at HK\$0.65 per share, 8.33% higher than its offer price of HK\$0.6. The price opened at HK\$0.76, with the most actively traded price of HK\$0.66 per share, and a turnover of 400,000 shares. The total trading volume reached 1,395,000 shares with **total turnover of HK\$927,250.00**. The final price of **INDIGO STAR**, to debut trading tomorrow has been fixed at HK\$0.6 per share.
