

**PhillipMart Announces Pre-IPO Share Price of
 Riverine China Holdings Limited (Stock code: 01417)**

(Hong Kong – 8 Dec 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Riverine China Holdings Limited** (Riverine China; stock code: 01417) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Riverine China on PhillipMart were HK\$1.64 and HK\$1.51. The price closed at HK\$1.59 per share, 2.58% higher than its offer price of HK\$1.55. The price opened at HK\$1.61, with the most actively traded price of HK\$1.59 per share, and a turnover of 1,688,000 shares. The total trading volume reached 5,478,000 shares with **total turnover of HK\$8,756,280.00**. The final price of Riverine China, to debut trading on 11 Dec. It has been fixed at HK\$1.55 per share.
