

PhillipMart Announces Pre-IPO Share Price of Nissin Foods Company Limited (Stock code: 1475)

(Hong Kong – 08 Dec 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Nissin Foods Company Limited ("Nissin Foods"; stock code: 01475) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Nissin Foods on PhillipMart were HK\$3.75 and HK\$3.21. The price closed at HK\$3.32 per share, 6.21% lower than its offer price of HK\$3.54. The price opened at HK\$3.7, with the most actively traded price of HK\$3.32 per share, and a turnover of 101,000 shares. The total trading volume reached 1,039,000 shares with **total turnover of \$3,500,450.00**. The final price of Nissin Foods, to debut trading on 11Dec. It has been fixed at HK\$3.54 per share.
