

**PhillipMart Announces Pre-IPO Share Price of
 SOLIS HOLDINGS LIMITED (Stock code: 02227)**

(Hong Kong – 8 Dec 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **SOLIS HOLDINGS LIMITED (SOLIS HOLDINGS;** stock code: 02227) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **SOLIS HOLDINGS** on PhillipMart were HK\$0.91 and HK\$0.7. The price closed at HK\$0.72 per share, 15.29% lower than its offer price of HK\$0.85. The price opened at HK\$0.91, with the most actively traded price of HK\$0.73 per share, and a turnover of 1,976,000 shares. The total trading volume reached 6,432,000 shares with **total turnover of HK\$4,868,880.00**. The final price of **SOLIS HOLDINGS**, to debut trading on 11 Dec. It has been fixed at HK\$0.85 per share.
