

**PhillipMart Announces Pre-IPO Share Price of
 Prosperous Printing Company Limited (Stock code: 08385)**

(Hong Kong – 12 Dec 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Prosperous Printing Company Limited (Prosperous Print; stock code: 08385) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Prosperous Print on PhillipMart were HK\$0.375 and HK\$0.32. The price closed at HK\$0.35 per share, its same with the offer price of HK\$0.35.
