

PhillipMart Announces Pre-IPO Share Price of Digital Hollywood Interactive Limited (Stock code: 02022)

(Hong Kong – 14 Dec 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Digital Hollywood Interactive Limited (Digital Hollywood**; stock code: 02022) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Digital Hollywood** on PhillipMart were HK\$0.7 and HK\$0.61. The price closed at HK\$0.66 per share,4.76% higher than its offer price of HK\$\$0.63. The price opened at HK\$0.62, with the most actively traded price of HK\$4.76 per share, and a turnover of 10,488,000shares. The total trading volume reached 24,936,000shares with **total turnover of HK\$16,788,320.00**. The final price of **Digital Hollywood**, to debut trading on 15 Dec. It has been fixed at HK\$0.63 per share.
