

PhillipMart Announces Pre-IPO Share Price of AV Promotions Holdings Limited (Stock code: 08419)

(Hong Kong – 20 Dec 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **AV Promotions Holdings Limited** (AV Promotions; stock code: 08419) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AV Promotions on PhillipMart were HK\$0.63 and HK\$0.58. The price closed at HK\$0.59 per share,7.27% higher than its offer price of HK\$0.55. The price opened at HK\$0.6, with the most actively traded price of HK\$0.59 per share, and a turnover of 2,240,000shares. The total trading volume reached 3,840,000shares with **total turnover of HK\$2,279,750.00**. The final price of AV Promotions, to debut trading on 21 Dec. It has been fixed at HK\$0.55 per share.
