

**PhillipMart Announces Pre-IPO Share Price of
 Vision International Holdings Limited (Stock code: 8107)**

(Hong Kong – 3 May 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Vision International Holdings Limited (“Vision International”; stock code: 8107) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Vision International on PhillipMart were HK\$0.243 and HK\$0.229. The price closed at HK\$0.229 per share, 1.78% higher than its offer price of HK\$0.225. The price opened at HK\$0.235, with the most actively traded price of HK\$0.24 per share, and a turnover of 3,070,000 shares. The total trading volume reached 16,510,000 shares with **total turnover of 3,899,790**. The final price of Vision International, to debut trading tomorrow has been fixed at HK\$0.225 per share.
