PhillipMart Announces Pre-IPO Share Price of

JLogo Holdings Limited (Stock code: 8527)

(Hong Kong – 08 May2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of JLogo Holdings Limited ("JLogo Hldgs"; stock code: 8527) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for JLogo Hldgs on PhillipMart were HK\$0.74 and HK\$0.57. The price closed at HK\$0.72 per share, 44.00% higher than its offer price of HK\$0.5. The price opened at HK\$0.57, with the most actively traded price of HK\$0.65 per share, and a turnover of 510,000 shares. The total trading volume reached 2,415,000 shares with **total turnover of 1,615,000.00**. The final price of JLogo Hldgs, to debut trading tomorrow has been fixed at HK\$0.5 per share.
