PhillipMart Announces Pre-IPO Share Price of HPC Holdings Limited (Stock code: 1742)

(Hong Kong – 10 May2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of HPC Holdings Limited ("HPC Holdings"; stock code: 1742) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for HPC Holdings on PhillipMart were HK\$0.5 and HK\$0.39. The price closed at HK\$0.425 per share, 5.56% lower than its offer price of HK\$0.45. The price opened at HK\$0.5, with the most actively traded price of HK\$0.4 per share, and a turnover of 4165000 shares. The total trading volume reached 24,220,000 shares with **total turnover of 10,203,850**. The final price of HPC Holdings, to debut trading tomorrow has been fixed at HK\$0.45 per share.
