

**PhillipMart Announces Pre-IPO Share Price of
 Tsit Wing International Holdings Limited (Stock code: 2119)**

(Hong Kong – 10 May 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Tsit Wing International Holdings Limited (“Tsit Wing INTL”; stock code: 2119) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tsit Wing INTL on PhillipMart were HK\$2.45 and HK\$2.05. The price closed at HK\$2.15 per share, 8.59% higher than its offer price of HK\$1.98. The price opened at HK\$2.2, with the most actively traded price of HK\$2.15 per share, and a turnover of 3,532,000 shares. The total trading volume reached 27,682,000 shares with **total turnover of 59,759,220.00**. The final price of Tsit Wing INTL, to debut trading tomorrow has been fixed at HK\$1.98 per share.
