

**PhillipMart Announces Pre-IPO Share Price of

on PhillipMart were HK\$1.36 and HK\$1.17. The price closed at HK\$1.35 per share, 19.47% higher than its offer price of HK\$1.13. The price opened at HK\$1.24, with the most actively traded price of HK\$1.25 per share, and a turnover of 8,481,000 shares. The total trading volume reached 46,188,000 shares with **total turnover of 58,716,090.00**. The final price of 21 Century Edu , to debut trading tomorrow has been fixed at HK\$1.13 per share.
