

**PhillipMart Announces Pre-IPO Share Price of
 LH Group Limited (Stock code: 1978)**

(Hong Kong – 29 May 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of LH Group Limited (“LH Group”; stock code: 1978) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for LH Group on PhillipMart were HK\$2.28 and HK\$1.42. The price closed at HK\$2.2 per share, 100% higher than its offer price of HK\$1.1. The price opened at HK\$1.45, with the most actively traded price of HK\$1.8 per share, and a turnover of 3,618,000 shares. The total trading volume reached 31,536,000 shares with **total turnover of 57,467,000.00**. The final price of LH Group, to debut trading tomorrow has been fixed at HK\$1.1 per share.
