PhillipMart Announces Pre-IPO Share Price of Amuse Group Holding Limited (Stock code: 8545)

(Hong Kong – 30 May 2018) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Amuse Group Holding Limited ("Amuse Group"; stock code: 8545) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Amuse Group on PhillipMart were HK\$0.4 and HK\$0.35. The price closed at HK\$0.37 per share, 5.71% higher than its offer price of HK\$0.35. The price opened at HK\$0.4, with the most actively traded price of HK\$0.365 per share, and a turnover of 55,176,000 shares. The total trading volume reached 113,848,000 shares with total turnover of 41,545,040.00. The final price of Amuse Group, to debut trading tomorrow has been fixed at HK\$0.35 per share.
