## PhillipMart Announces Pre-IPO Share Price of MS Group Holdings Limited (Stock code: 1451)

(Hong Kong – 31 May 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of MS Group Holdings Limited ("MS Group"; stock code: 1451) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for MS Group on PhillipMart were HK\$2 and HK\$1.61. The price closed at HK\$1.85 per share, 38.06% higher than its offer price of HK\$1.34. The price opened at HK\$1.8, with the most actively traded price of HK\$1.85 per share, and a turnover of 2,356,000 shares. The total trading volume reached 11,086,000 shares with **total turnover of 20,339,220.00**. The final price of MS Group, to debut trading tomorrow has been fixed at HK\$1.34 per share.
