PhillipMart Announces Pre-IPO Share Price of Tian Yuan Group Holdings Limited (Stock code: 6119)

(Hong Kong – 31 May 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tian Yuan Group Holdings Limited ("Tian Yuan Gp"; stock code: 6119) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tian Yuan Gp on PhillipMart were HK\$1 and HK\$0.77. The price closed at HK\$0.77 per share, 9.41% lower than its offer price of HK\$0.85. The price opened at HK\$1, with the most actively traded price of HK\$0.8 per share, and a turnover of 1,212,000 shares. The total trading volume reached 5,496,000 shares with **total turnover of 4,552,830.00**. The final price of Tian Yuan Gp, to debut trading tomorrow has been fixed at HK\$0.85 per share.
