

PhillipMart Announces Pre-IPO Share Price of Affluent Foundation Holdings Limited (Stock code: 1757)

(Hong Kong – 06 June 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Affluent Foundation Holdings Limited ("Affluent FDN"; stock code: 1757) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Affluent FDN on PhillipMart were HK\$0.41 and HK\$0.36. The price closed at HK\$0.365 per share, 7.35% higher than its offer price of HK\$0.34. The price opened at HK\$0.4, with the most actively traded price of HK\$0.375 per share, and a turnover of 14,120,000 shares. The total trading volume reached 48,590,000 shares with **total turnover of 18,360,700.00**. The final price of Affluent FDN, to debut trading tomorrow has been fixed at HK\$0.34 per share.
