

**PhillipMart Announces Pre-IPO Share Price of  
 Dowway Holdings Limited (Stock code: 8403)**

(Hong Kong – 11 June 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Dowway Holdings Limited (“Dowway”; stock code: 8403) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dowway on PhillipMart were HK\$0.158 and HK\$0.14. The price closed at HK\$0.148 per share, 2.07% higher than its offer price of HK\$0.145. The price opened at HK\$0.146, with the most actively traded price of HK\$0.15 per share, and a turnover of 21,960,000 shares. The total trading volume reached 62,540,000 shares with **total turnover of 9,413,269.00**. The final price of Dowway, to debut trading tomorrow has been fixed at HK\$0.145 per share.
