

## PhillipMart Announces Pre-IPO Share Price of Huifu Payment Limited (Stock code: 1806)

(Hong Kong – 14 June 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Huifu Payment Limited ("Huifu Payment"; stock code: 1806) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Huifu Payment on PhillipMart were HK\$7.35 and HK\$6.8. The price closed at HK\$6.89 per share, 8.13% lower than its offer price of HK\$7.5. The price opened at HK\$6.8, with the most actively traded price of HK\$6.9 per share, and a turnover of 466,800 shares. The total trading volume reached 1,662,800 shares with **total turnover of 11,502,052.00**. The final price of Huifu Payment, to debut trading tomorrow has been fixed at HK\$7.5 per share.
