

PhillipMart Announces Pre-IPO Share Price of Republic Healthcare Limited (Stock code: 8357)

(Hong Kong – 14 June 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Republic Healthcare Limited ("Republic HC"; stock code: 8357) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Republic HC on PhillipMart were HK\$0.67 and HK\$0.6. The price closed at HK\$0.64 per share, 6.67% higer than its offer price of HK\$0.6. The price opened at HK\$0.64, with the most actively traded price of HK\$0.64 per share, and a turnover of 4,745,000 shares. The total trading volume reached 15,180,000 shares with **total turnover of 9,789,050.00**. The final price of Republic HC, to debut trading tomorrow has been fixed at HK\$0.6 per share.
