

PhillipMart Announces Pre-IPO Share Price of VCredit Holdings Limited (Stock code: 2003)

(Hong Kong – 20 June 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of VCredit Holdings Limited ("Vcredit"; stock code: 2003) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Vcredit on PhillipMart were HK\$20.35 and HK\$18.04. The price closed at HK\$20.2 per share, 1.00% higer than its offer price of HK\$20. The price opened at 18.5, with the most actively traded price of HK\$20 per share, and a turnover of 146,600 shares. The total trading volume reached 775,200 shares with **total turnover of 15,379,400.00**. The final price of Vcredit, to debut trading tomorrow has been fixed at HK\$20 per share.
