PhillipMart Announces Pre-IPO Share Price of Shineroad International Holdings Limited (Stock code: 1587)

(Hong Kong – 26 June 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Shineroad International Holdings Limited ("Shineroad INTL"; stock code: 1587) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Shineroad INTL on PhillipMart were HK\$0.75 and HK\$0.69. The price closed at HK\$0.7 per share, 6.67% lower than its offer price of HK\$0.75. The price opened at HK\$0.75, with the most actively traded price of HK\$0.73 per share, and a turnover of 1,728,000 shares. The total trading volume reached 5,652,000 shares with **total turnover of 4,073,080.00**. The final price of Shineroad INTL, to debut trading tomorrow has been fixed at HK\$0.75 per share.
