

## PhillipMart Announces Pre-IPO Share Price of Shanshan Brand Management Company Limited (Stock code: 1749)

(Hong Kong – 26 June 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Shanshan Brand Management Company Limited ("Shanshan"; stock code: 1749) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Shanshan on PhillipMart were HK\$4.45 and HK\$3.95. The price closed at HK\$4.32 per share, 14.29% higher than its offer price of HK\$3.78. The price opened at HK\$3.95, with the most actively traded price of HK\$4.1 per share, and a turnover of 695,000 shares. The total trading volume reached 4762000 shares with **total turnover of 20,183,910.00**. The final price of Shanshan, to debut trading tomorrow has been fixed at HK\$3.78 per share.
