

PhillipMart Announces Pre-IPO Share Price of Grace Wine Holdings Limited (Stock code: 8146)

(Hong Kong – 26 June 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Grace Wine Holdings Limited ("Grace Wine"; stock code: 8146) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Grace Wine on PhillipMart were HK\$0.42 and HK\$0.35. The price closed at HK\$0.41 per share, 17.14% higher than its offer price of HK\$0.35.
