

PhillipMart Announces Pre-IPO Share Price of Wise Talent Information Technology Co., Ltd (Stock code: 6100)

(Hong Kong – 28 June 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wise Talent Information Technology Co., Ltd ("Talent Liepin"; stock code: 6100) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Talent Liepin on PhillipMart were HK\$31 and HK\$29.15. The price closed at HK\$30.2 per share, 8.48% lower than its offer price of HK\$33. The price opened at HK\$30.05, with the most actively traded price of HK\$30 per share, and a turnover of 20,800 shares. The total trading volume reached 135,000 shares with **total turnover of 4,056,350.00**. The final price of Talent Liepin, to debut trading tomorrow has been fixed at HK\$33 per share.
