

**PhillipMart Announces Pre-IPO Share Price of
 Tong Kee (Holding) Limited (Stock code: 8305)**

(Hong Kong – 03 July 2018) Phillip Securities (HK) Ltd. (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Tong Kee (Holding) Limited (“Tong Kee HLDG”; stock code: 8305) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tong Kee HLDG on PhillipMart were HK\$0.345 and HK\$0.31. The price closed at HK\$0.325 per share, 8.33% higher than its offer price of HK\$0.3. The price opened at 0.31, with the most actively traded price of HK\$0.33 per share, and a turnover of 3,100,000 shares. The total trading volume reached 9,270,000 shares with **total turnover of 3,065,050.00**. The final price of Tong Kee HLDG, to debut trading tomorrow has been fixed at HK\$0.3 per share.
