PhillipMart Announces Pre-IPO Share Price of Tong Kee (Holding) Limited (Stock code: 8305)

(Hong Kong – 03 July 2018) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tong Kee (Holding) Limited ("Tong Kee HLDG"; stock code: 8305) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tong Kee HLDG on PhillipMart were HK\$0.345 and HK\$0.31. The price closed at HK\$0.325 per share, 8.33% higher than its offer price of HK\$0.3. The price opened at 0.31, with the most actively traded price of HK\$0.33 per share, and a turnover of 3,100,000 shares. The total trading volume reached 9,270,000 shares with total turnover of 3,065,050.00. The final price of Tong Kee HLDG, to debut trading tomorrow has been fixed at HK\$0.3 per share.
