

**PhillipMart Announces Pre-IPO Share Price of  
 China Isotope & Radiation Corporation (Stock code: 1763)**

(Hong Kong – 05 July 2018 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of China Isotope & Radiation Corporation (“CIRC”; stock code: 1763) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CIRC on PhillipMart were HK\$22.1 and HK\$19.5. The price closed at HK\$19.86 per share, 8.06% lower than its offer price of HK\$21.6. The price opened at HK\$21.8, with the most actively traded price of HK\$19.8 per share, and a turnover of 315,200 shares. The total trading volume reached 1,600,600 shares with **total turnover of 32,820,558.00**. The final price of CIRC, to debut trading tomorrow has been fixed at HK\$21.6 per share.
