

**PhillipMart Announces Pre-IPO Share Price of
 Xiaomi Corporation (Stock code: 1810)**

(Hong Kong – 06 July 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Xiaomi Corporation (“Xiaomi”; stock code: 1810) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Xiaomi on PhillipMart were HK\$16.72 and HK\$16. The price closed at HK\$16.1 per share, 5.29% lower than its offer price of HK\$17. The price opened at HK\$16, with the most actively traded price of HK\$16.4 per share, and a turnover of 564,400 shares. The total trading volume reached 4671,400 shares with **total turnover of 76,226,576.00**. The final price of Xiaomi, to debut trading tomorrow has been fixed at HK\$17 per share.
