PhillipMart Announces Pre-IPO Share Price of ZIYUANYUAN HOLDINGS GROUP LIMITED (Stock code: 8223)

(Hong Kong – 06 July 2018) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of ZIYUANYUAN HOLDINGS GROUP LIMITED ("ZYY"; stock code: 8223) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ZYY on PhillipMart were HK\$1.52 and HK\$0.94. The price closed at HK\$1.43 per share, 88.16% higher than its offer price of HK\$0.76. The price opened at HK\$HK\$0.99, with the most actively traded price of HK\$1.36 per share, and a turnover of 260,000 shares. The total trading volume reached 3,080,000 shares with total turnover of 4,012,280.00. The final price of ZYY, to debut trading tomorrow has been fixed at HK\$0.76 per share.
