

PhillipMart Announces Pre-IPO Share Price of Bank of Jiujiang Co., Ltd (Stock code: 6190)

(Hong Kong – 09 July 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Bank of Jiujiang Co., Ltd ("Bank of Jiujiang"; stock code: 6190) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bank of Jiujiang on PhillipMart were HK\$10.64 and HK\$10.46. The price closed at HK\$10.64 per share, 0.38% higher than its offer price of HK\$10.6. The price opened at 10.6, with the most actively traded price of HK\$10.6 per share, and a turnover of 158,600 shares. The total trading volume reached 176,600 shares with **total turnover of 1,871,976.00**. The final price of Bank of Jiujiang, to debut trading tomorrow has been fixed at HK\$10.6 per share.
