

PhillipMart Announces Pre-IPO Share Price of Fusen Pharmaceutical Company Limited (Stock code: 1652)

(Hong Kong – 10 July 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Fusen Pharmaceutical Company Limited ("Fusen Pharm"; stock code: 1652) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Fusen Pharm on PhillipMart were HK\$2.48 and HK\$2.18. The price closed at HK\$2.42 per share, 16.35% higher than its offer price of HK\$2.08. The price opened at HK\$2.18, with the most actively traded price of HK\$2.4 per share, and a turnover of 1,228,000 shares. The total trading volume reached 6,125,000 shares with **total turnover of 14,400,720.00**. The final price of Fusen Pharm, to debut trading tomorrow has been fixed at HK\$2.08 per share.
