

**PhillipMart Announces Pre-IPO Share Price of
 Man Shun Group (Holdings) Limited (Stock code: 1746)**

(Hong Kong – 10 July 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Man Shun Group (Holdings) Limited (“Man Shun GP”; stock code: 1746) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Man Shun GP on PhillipMart were HK\$0.58 and HK\$0.5. The price closed at HK\$0.51 per share, 1.92% lower than its offer price of HK\$0.52. The price opened at HK\$0.58, with the most actively traded price of HK\$0.53 per share, and a turnover of 15,604,000 shares. The total trading volume reached 34,068,000 shares with **total turnover of 17,834,960.00**. The final price of Man Shun GP, to debut trading tomorrow has been fixed at HK\$0.52 per share.
