

PhillipMart Announces Pre-IPO Share Price of Intron Technology Holdings Limited (Stock code: 1760)

(Hong Kong – 11 July 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Intron Technology Holdings Limited ("Intron Tech"; stock code: 1760) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Intron Tech on PhillipMart were HK\$3.1 and HK\$2.82. The price closed at HK\$3.06 per share, 高 5.52% higher than its offer price of HK\$2.9. The price opened at HK\$HK\$2.82, with the most actively traded price of HK\$3.08 per share, and a turnover of 417000 shares. The total trading volume reached 1877000 shares with **total turnover of 5728920.00**. The final price of Intron Tech, to debut trading tomorrow has been fixed at HK\$2.9 per share.
