

PhillipMart Announces Pre-IPO Share Price of Tianli Education International Limited (Stock code: 1773)

(Hong Kong – 11 July 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tianli Education International Limited ("Tianli Edu"; stock code: 1773) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tianli Edu on PhillipMart were HK\$3.11 and HK\$2.66. The price closed at HK\$3.02 per share, 13.53% higher than its offer price of HK\$2.66. The price opened at HK\$HK\$2.66, with the most actively traded price of HK\$3 per share, and a turnover of 1,575,000 shares. The total trading volume reached 6,181,000 shares with **total turnover of 18,361,600.00**. The final price of Tianli Edu, to debut trading tomorrow has been fixed at HK\$2.66 per share.
