## **PhillipMart Announces Pre-IPO Share Price of Redsun Properties Group Limited (Stock code: 1996)**

(Hong Kong – 11 July 2018) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Redsun Properties Group Limited ("RSUN PPT"; stock code: 1996) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for RSUN PPT on PhillipMart were HK\$2.48 and HK\$2.3. The price closed at HK\$2.47 per share, 8.33% higher than its offer price of HK\$2.28. The price opened at HK\$HK\$2.31, with the most actively traded price of HK\$2.31 per share, and a turnover of 174,000 shares. The total trading volume reached 978,000 shares with total turnover of 2,328,460.00. The final price of RSUN PPT, to debut trading tomorrow has been fixed at HK\$2.28 per share.
