

PhillipMart Announces Pre-IPO Share Price of FingerTango Inc. (Stock code: 6860)

(Hong Kong – 11 July 2018) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of FingerTango Inc. ("FingerTango"; stock code: 6860) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for FingerTango on PhillipMart were HK\$2.08 and HK\$1.81. The price closed at HK\$2.08 per share, 0.48% higher than its offer price of HK\$2.07. The price opened at HK\$HK\$2.07, with the most actively traded price of HK\$2.02 per share, and a turnover of 398,000 shares. The total trading volume reached 2,339,000 shares with **total turnover of 4,674,160.00**. The final price of FingerTango, to debut trading tomorrow has been fixed at HK\$2.07 per share.
