

PhillipMart Announces Pre-IPO Share Price of BOSA TECHNOLOGY HOLDINGS LIMITED (Stock code: 8140)

(Hong Kong – 11 July 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of BOSA TECHNOLOGY HOLDINGS LIMITED ("BOSA TECH"; stock code: 8140) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BOSA TECH on PhillipMart were HK\$0.54 and HK\$0.4. The price closed at HK\$0.495 per share, 65.00% higher than its offer price of HK\$0.3. The price opened at HK\$HK\$0.4, with the most actively traded price of HK\$0.49 per share, and a turnover of 2,460,000 shares. The total trading volume reached 14,080,000 shares with **total turnover of 6,879,450.00**. The final price of BOSA TECH, to debut trading tomorrow has been fixed at HK\$0.3 per share.
