

PhillipMart Announces Pre-IPO Share Price of Prosperous Industrial (Holdings) Limited (Stock code: 1731)

(Hong Kong – 12 July 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Prosperous Industrial (Holdings) Limited (“Prosperous Ind”; stock code: 1731) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Prosperous Ind on PhillipMart were HK\$1.14 and HK\$0.85. The price closed at HK\$0.91 per share, 2.25% higher than its offer price of HK\$0.89. The price opened at HK\$0.92, with the most actively traded price of HK\$0.94 per share, and a turnover of 1432000 shares. The total trading volume reached 11,992,000 shares with **total turnover of 11,544,520.00**. The final price of Prosperous Ind, to debut trading tomorrow has been fixed at HK\$0.89 per share.
