

PhillipMart Announces Pre-IPO Share Price of Kinergy Corporation Ltd. (Stock code: 3302)

(Hong Kong – 17July 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Kinergy Corporation Ltd. ("Kinergy"; stock code: 3302) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kinergy on PhillipMart were HK\$1.34 and HK\$1.2. The price closed at HK\$1.23 per share, 5.13% higher than its offer price of HK\$1.17. The price opened at HK\$HK\$1.2, with the most actively traded price of HK\$1.24 per share, and a turnover of 1,396,000 shares. The total trading volume reached 4,038,000 shares with **total turnover of 5,076,380.00**. The final price of Kinergy, to debut trading tomorrow has been fixed at HK\$1.17 per share.
