

PhillipMart Announces Pre-IPO Share Price of Pacific Legend Group Limited (Stock code: 8547)

(Hong Kong – 17July 2018) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Pacific Legend Group Limited ("Pacific Legend"; stock code: 8547) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Pacific Legend on PhillipMart were HK\$0.63 and HK\$0.41. The price closed at HK\$0.6 per share, 100.00% higher than its offer price of HK\$0.3. The price opened at HK\$HK\$0.41, with the most actively traded price of HK\$0.6 per share, and a turnover of 2,590,000 shares. The total trading volume reached 10,510,000 shares with **total turnover of 6,049,400.00**. The final price of Pacific Legend, to debut trading tomorrow has been fixed at HK\$0.3 per share.
