

**PhillipMart Announces Pre-IPO Share Price of  
 E-House (China) Enterprise Holdings Limited (Stock code: 2048)**

(Hong Kong – 19 July 2018) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of E-House (China) Enterprise Holdings Limited (“E-House (China) Ent”; stock code: 2048) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for E-House (China) Ent on PhillipMart were HK\$14.5 and HK\$13.6. The price closed at HK\$13.9 per share, 3.34% lower than its offer price of HK\$14.38. The price opened at HK\$14.5, with the most actively traded price of HK\$13.86 per share, and a turnover of 132,600 shares. The total trading volume reached 858,300 shares with **total turnover of 11,983,770.00**. The final price of E-House (China) Ent, to debut trading tomorrow has been fixed at HK\$14.38 per share.
